General information

Transportable containers within the meaning of German standard TRGS 510 include tank containers (road semi-trailers) or rail tank cars.

When storing explosive mixtures, protective measures must be taken on the vessels in accordance with the German industrial safety regulation (BetrSichV). Further safety measures such as maintaining pressure may also be required during emptying, filling, cleaning, maintenance and repair.

Under the brand name KITO[®], safety concepts for explosion protection and pressure holding for stationary and mobile plant components have been developed and corresponding valves produced in Braunschweig for over 90 years.

Special areas of application for KITO[®] valves are the protection of rail tank cars or tank vehicles.






Image1: KITO[®] K/CVO-80

Combined overpressure and vacuum quick release valve with low overall height.




Image 2: KITO® KV/G

Deflagration-proof vacuum valve with low overall height for flammable liquids and gases up to explosion group IIA and a function control device for the valve head.





Image 3: KITO® K/DVE-IIB3-80





Image 4: KITO® DE/cont. 20

Uni-directional detonation flame arrester for installation in pipelines to protect vessels and plant components. Suitable for all substances in explosion groups IIA1 to IIA.










Image 9: KITO® VS/o cont.
